## WHAT'S HAPPENING THIS MONTH

Dress warmly! Sheets and blankets should be available. We will be staying in heated buildings, but to be safe take your own sleeping bag if you desire.

Chow will be contracted from the Hoosier Kitchen Saturday morning. The Saturday morning meal will be served at the Camp Atterbury airfield from murmite cans. A bus will transport personnel to the Hoosier Kitchen Saturday evening and Sunday morning. The Saturday noon meal and the Sunday noon meal will be C rations. Every person scheduled to go to Camp Atterbury will draw his two C-rations from AASF #2 flight operations prior to departing OSU.

All support personnel will be transported in unit aircraft. Pilots available for early departures on Friday will have to wait until their aircraft have sufficient passengers. #### FIRST SERGEANT SPEAKS

1ST Sergeant, Platoon Sergeant Section Leader (Enlisted) meeting 1800 hrs Friday 24 Apr 81 at the flight facility in the T.I. library.

## MAINTENANCE

There have been some important changes in TM 55-1500-204-25/1 - The General Aircraft Maintenance Manual concerning the marking and inspection of restriant equipment and damage limits of aircraft cables. Everyone should review these changes as soon as possible.

Shoulder harness and seat belts are no longer calendar replacement items, therefore they should have a thorough inspection when the aircraft is dailied. The restraint equipment should be marked with the installation date in indelable ink (not black paint), with a minimum height of one inch letters.

For complete instructions on the daily inspection, replacement, replacement and marking of restraint equipment you should read Para. 3-305 through 3-314 in TM 55-1500-204-25/1.

The requirement on the UH-1 to purge the tail rotor grips after the aircraft has been flown in the rain is now in both the C and M, and D and H manuals.

There seems to be some problem areas on the 2408-13's, in block 9 "next inspection due" when a special inspection or phase is completed, be sure to line through the inspection time and add the new time above the lined out time.

Oil sample Forms: There has been a couple of changes on the oil sample forms, the first is that the individual taking the oil sample will print his name in the remarks section of the form. The other change is a address which is "AOPA-LAB P.O. Box J Ft Knox, KY 41021.

## MAINTENANCE cont.

Aircraft Structural Panels
In the UH-1 H and M model manuals it states that the aircraft will not be jacked, towed, ground run or flown with panels and access doors removed, these panels and access doors are shown in Chapter 2, Airframe section in both manuals. In checking with TSARCOM in St. Louis, they say, if all the panels are removed, as during a phase, the panels must be installed before you move or jack the aircraft. So plan your work so the panels are reinstalled before jacking or moving the aircraft.

#### SPRING FEVER:

Transfer of Cold Weather Coat (LIN E43851) from an Organizational Item to a Personal (Clothing Bag) Item

SEE DISTRIBUTION

- 1. Reference: DA Circular 700-31, 15 May 1980.
- 2. DA Circular 700-31 announced the transfer of the field jacket from an organizational item to a personal issue item effective 1 October 1980. As of that date the field jacket became an item of personal issue to enlisted personnel and will be purchased by officers. The basis of issue is one per enlisted member. This includes enlisted members who are on clothing maintenance allowance. ARNG members entering basic training will be issued two field jackets at the training center. Upon return to home station the unit will withdraw one, make a turn-in entry of DA Form 3074/DA Form 4886, and turn the item in to the USPFO Warehouse.

ACON-PF-COF will effect necessary administrative action to forward

- 3. At the present time, all field jackets for enlisted personnel are accounted for on DA Form 3078 and no change is required.
- 4. All field jackets issued to officers should be charged on their DA Form 3645. Officers may, if they desire, purchase presently issued field jackets at 50 percent of AMDF price of \$28.10 or \$14.05. If not purchased, officer personnel will turn in organizational field jackets upon leaving the ARNG or home State for PCS.

## PROCEDURE FOR PURCHASE OF FIELD JACKET

- 1. Each officer issued a field jacket will be made aware of this new policy and will be queried as to their desire to purchase the presently issued field jacket.
- 2. Officers who elect to purchase their issued field jacket may pay for this item using DD Form 1131 (Cash Collection Voucher). The use of DD Form 1131 for collection of payment is an exception to AR/NGR 735-11 for this one time purpose only.
- 3. Sales Procedures: a. The officer will furnish a check or money order payable to the "Treasurer of the United States" to the unit AST:
- b. The AST will prepare DD Form 1131 (sample attached). DD Form 1131 will be forwarded to AGOH-PF-COF in seven copies.
- c. AGOH-PF-COF will effect necessary administrative action to forward DD Form 1131 to the Finance Officer for completion of collection action. Upon assignment of "Receiving Office Collection Voucher No" by AGOH-PF-COF, two copies will be returned to the unit for each name appearing thereon. These copies will be regarded as action having been completed since they will bear the signature of the USPFO and the assigned voucher number.
- 4. Property Accountability Procedures: a. Currently all field jackets issued to officers should be accounted for on DA Form 3645 which is maintained in their Individual Clothing Form File (ICFF). A suspense copy of DD Form 1131 will be filed in the ICFF pending receipt of action copy from USPFO.
- b. Upon receipt of the vouchered copy from AGOH-PF-COF, unit will file one copy of DD Form 1131 in the officers' ICFF and credit the DA Form 3645 with turnin of the item.
- c. Unit will furnish one copy of the vouchered DD Form 1131 to the officer as proof of ownership.
- d. AGOH-PF-COF will furnish one paid copy of DD Form 1131 to AGOH-PF-LOS (Reconciliation Section) for the examiner's control file.
- 5. Officers who do not elect to purchase the field jacket at this time will have accountability maintained on DA Form 3645. Property book accountability will be established and maintained on these jackets. Officers will be cleared of all property upon leaving the ARNG or State on PCS.
- 6. No issue of jackets to officer or warrant officer personnel will be made after the date of this letter. Field jackets issued to officers not electing to purchase the item will not be replaced when salvaged or otherwise disposed of.
- 7. Units are reminded that the Liner Cold Weather Coat (LIN L70172) is a separate item and is not included in this action.
- 8. Coat Mans Cold Weather may be purchased at Clothing Sales Stores established at active army installations or use may be made of their mail order service.
- 9. A cut-off date of 1 June 1981 is established for completion of this action.
  Officers not electing to purchase by the cut-off date will not have the option to buy at a later date.

#### EXPLANATION OF INACTIVE DUTY FOR TRAINING (IDT) LEAVE AND EARNINGS STATEMENT (LES)

The LES is a computer-produced monthly statement of account for each soldier paid by the Joint Uniform Military Pay System - Reserve Component (JUMPS-RC). It shows all entitlements, collections, and payments made during the period covered. Every ARNG soldier should receive an LES on a monthly basis. Detailed block description of the LES is as follows:
